1 Summary of Performance

1.A Introduction

This Budget Performance Report for Gombe State is prepared quarterly, and issued within 4 weeks from the end of each quarter.

This report includes, the approved original budget appropriation for the year 2021 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q2, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations. No supplementary/revised budget has been passed to date.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23 / 32
- Others Economic Account Classes 2203-2208 as applicable

This Budget Performance Report is produced by the Budget Directorate of the Budget, Planning and Development Partner Coordination Office (BP&DPCO) as well as the Office of the State Accountant General, Ministry of Finance; and published on the Gombe State Ministry of Finance website.

1.B Revenue Performance

The quarter 2, 2021 (April – June) budget performance shows actual Recurrent Receipts of N15,338,511,454.87 in the quarter out of the total annual estimated sum N76,286,513,000.00 which is 20.1%. The overall year to date figure summing up from January to June 2021 is N29,399,946,046.00 constituting 38.5% actual recurrent receipts for the half year.

Recurrent receipts is made up of allocations from the Federation Account and the State Internally Generated Revenue (Independent Revenue).

This performance is below expectation but fair considering the economic situation prevalent including the waves and/or resurgence of COVID-19 with its socio-economic consequences. However, more efforts will need to be made especially in Internally Generated Revenue (IGR).

Government share of FAAC (Statutory Revenue) amounted to N13,024,864,986.89 during the period under review (April to June 2021) constituting 20.9% out of the annual projection of N62,200,000,000.00; while IGR collected in the same period amounted to N2,313,646,467.98 which is 16.4% of the projected N14,086,513,000.00. When added to the quarter one collections, overall Statutory Revenue amounts to N24,674,974,933.87 constituting overall 39.7% for the half year while that of IGR amount to N4,724,971,130.13 for the half year constituting 33.5%.

1.C Recurrent Expenditure Performance

The Recurrent Expenditure constitute Personnel costs, Overhead costs and Public Debt Charges. During the period January to June under review, Recurrent Expenditure amounted to N26,768,997,631.55 which is 45.6% of the projected N58,681,081,626.00.

Out of the said N26,768,997,631.55, Personnel costs amounted to N13,549,952,162.57, Overhead costs amounted to N5,804,908,227.83 while Public Debt Charges amounted to N7,414,497,241.15.

1.D Capital Expenditure Performance

The 2021 budgeted Capital Expenditure amounts to the sum of N61,665,455,000.00.

Out of this figure, performance during the period April – June amounts to N12,961,785,734.12. This represents 21.1% performance only.

The January to June overall performance, however, stands at N16,531,793,500.58 constituting 26.8%. Performance is expected to rise as the year progresses.

1.E Conclusions

Considering the above, it may be noted that the overall budget performance in quarter 2 covering January to June 2021 stands at 36.0%. Indicating a total expenditure of N43,300,791,132.13 out of the total budget size of N120,346,536,626.00. The performance is encouraging particularly in recurrent expenditure as government spending trends indicate usually more performance in the 3rd and 4th quarters. More will need to be done on capital expenditure though.

Note

Several unexpected receipts (IGR and Capital receipts) and over expending by some MDAs especially Office of the Accountant General (Financial Consulting) which are reflected in the figures in this report will be addressed during Supplementary Budget later in quarter 3.
