Short Application Guidelines and Key steps in the processing of an application for Consent to Mortgage (MOT)

- 1. An R-of-O Title Holder who wants to apply for Consent to Mortgage must apply with this MOT form.
- 2. The Applicant must also complete a UCO form with the details of the Bank (Mortgagee).
- 3. Payment for the Processing Fee must be made into the GOGIS TSA Account.
- 4. Evidence of Payment needs to be submitted with the completed application forms (MOT and UCO) and the required documents (see details above).
- 5. The Applicant must then pay a Stamping and Registration Fee of 2.5% of the Mortgage amount.
