R-of-O Title Holders who want to extend their registered property to a Land NOT registered, must apply with this PEX form for Plot Extension. A proof of Ownership such as Change of Ownership and Clearance Form from Local Government or Allocation Letter for the Land NOT registered is required. The Application Form PEX must be attached to the UCI for Private Individuals or UCO for Organisations. MLS Town Planning will contact the Applicant for a Site Inspection.

**Please note: Plot Extension is for 1 registered (titled) Land and 1 unregistered (untitled) Land. R-of-O Title Holder with registered Titles who want to extend their Property into a registered Land (2 registered Title), must apply for Plot Merger with the Application Form for Plot Merger MPI or MPO.**
