### 1 Summary of Performance

#### 1.A Introduction

This Budget Performance Report for Gombe State is prepared quarterly, and issued within 4 weeks from the end of each quarter.

This report includes, the approved budget appropriation for the year 2021 against each organizational unit for each of the core economic classification of expenditures (Personnel, Overheads, Capital, and Others); the actual expenditures for the quarter Q1, attributed to each organizational unit, as well as the cumulative expenditures for year to date, and balances against each of the revenue and expenditure appropriations.

The core economic classifications refer to:

- Personnel Economic Sub-Account Type 21, and Economic Account Class
   2201
- Overheads Economic Account Class 2202
- Capital Economic Sub-Account Type 23 / 32
- Others Economic Account Classes 2203-2208 as applicable

This Budget Performance Report is produced by the Budget Directorate of Budget, Planning and Development Partner Coordination Office as well as the Office of the State Accountant General, Ministry of Finance; and published on the Gombe Ministry of Finance website.

#### 1.B Revenue Performance

The quarter 1, 2021 (January – March) budget performance shows a positive start in the year with actual overall Recurrent Receipts of N14,061,434,069.13 out of the estimated sum N76,286,513,000.00 which is 18.4%.

Recurrent receipts is made up of allocations from the Federation Account and the State Internally Generated Revenue (Independent Revenue).

This performance is impressive considering that the year has just began and collections especially of Internally Generated Revenue (IGR) which normally is slow during the beginning of each year.

Government share of FAAC (Statutory Revenue) amounted to N11,650,109,946.98 during the period under review (January to March 2021) constituting 18.7% out of the annual projection of N62,200,000,000.00; while IGR collected in the same period amounted to N2,411,324,662.15 which is 17.1% of the projected N14,086,513,000.00. We are optimistic that revenue collections will gather momentum as the year progresses.

#### 1.C Recurrent Expenditure Performance

The Recurrent Expenditure constitute Personnel costs, Overhead costs and Public Debt Charges. During the period under review, Recurrent Expenditure amounted to N12,881,677,226.74 which is 22.0% of the projected N58,681,081,626.00.

Out of the said N12,881,677,226.74, Personnel costs amounted to N6,926,794,291.42; Overhead costs amounted to N2,286,168,178.92 while Consolidated Revenue Fund Charges (CRFC) amounted to N3,668,714,756.40.

#### 1.D Capital Expenditure Performance

The 2021 budgeted Capital Expenditure amounts to the sum of N61,665,455,000.00.

Out of this figure, performance during the period January – March amounts to N3,273,208,238.68. This represents 5.3% performance only. With the year starting newly, projects executions are expected to increase with expected payments to contractors to push for more projects delivery towards meeting the yearning of the people. Performance will rise dramatically as the year progresses.

#### 1.E Conclusions

Considering the above, it may be noted that the overall budget performance in quarter 1 of 2021 stands at 13.4%. Indicating a total expenditure of N16,154,885,465.42 out of the total budget size of N120,346,536,626.00. The performance is very encouraging particularly in recurrent expenditure. More need to be done on capital expenditure.

In view of the zeal and enthusiasm of the present administration, government is expected to perform at least 90% if not more in 2021.
